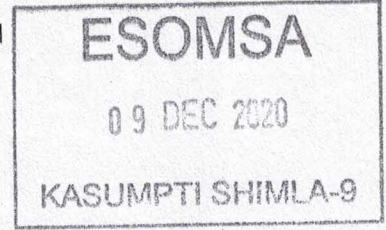

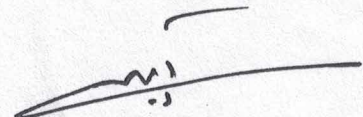
महोदय,

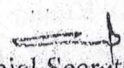
