Short title & commencement

1. These rules shall be called Himachal Pradesh Grant of Housing Subsidy to Backward Classes (Ninth amendment) Rules, 2004. ✓

2. These rules shall be deemed to have come into force with effect from the date of issue of this notification.

Amendment of proviso of Rule 3(1)

In pursuance of provisions contained in H.P. Grant of Housing Subsidy to Backward Classes (Tenth amendment) Rules 2005, the Governor, Himachal Pradesh, is pleased to enhance the existing housing subsidy being given to SCs/STs and OBCs by the State Government, as under:-

- 1) For construction of house from existing Rs. 27,500/- to Rs. 38,500/-.
- 2) For repairs/upgradation from existing Rs. 12,500/- to Rs. 15,000/-.
2. This enhancement is made subject of the condition that no additional budget will be provided for the purpose during the current financial year 2008-09.
