

- Short title & commencement. 1. (1) These rules shall be called the Himachal Pradesh Grant of Housing Subsidy to Backward Classes (Amendment) Rules, 1975.
- (2) These rules shall be deemed to have come into force with effect from the date of issue of this notification. ✓

The Governor of Himachal Pradesh is pleased to make the following rules to amend the Himachal Pradesh Grant of Housing subsidy to Backward Classes Rules 1975 as notified vide notification no.22-2-69 Vol-II- Wel-Sectt. dated the 22nd August 1975 and notification of even no. dated the December 1977 and 29th September 1978 namely:-

Short title and
commencement

- 1.(1) These rules shall be called the Himachal Pradesh Grant of Housing Subsidy to Backward Classes (3rd amendment) Rules 1980
- (2) These shall come into force with immediate effect.

Amendment of
Rule 3(1)

After sub Rule (III) of rule 3(1) of the HP Grant of Housing Subsidy to Backward Classes Rules 1975 the sub rule (IV) shall be added as under:-

“(IV) Electrification of Houses”.

Amendment of
Rule 3(2)

After sub rule (c) of rule 3(2) of the above said rules the sub rule (d) shall be added as under:-

“(d) Preference shall be given to those engaged in unclean occupation and unable to finance the expenditure for electrification.

Amendment of
Rule 6

After sub rule (C) of rule 6 of the said rules the sub rule(d) shall be added as under:-

“(d) the applicant desirous may apply for subsidy for electrification of houses, on this application form given at Annexure -II

Amendment of
Rule 7

After sub rule (d) of rule 7 of the said rules the sub
rule(e) shall be added as under:-

“(e) for electrification subsidy upto Rs.200 -per
family shall be given”.

Amendment of
Rule 8

After sub rule (c) of the rule 8 of the said rules the sub
rule(f) shall be added as under:-

“(f) The grant for electrification shall be released in
two installments : first installment amounting to 50 %
of this sanctioned amount of the electrification is
proposed to be undertaken and balance 50 % when the
electrification has been completed .”
